To be considered for membership in CTR, Charities or their affiliates must fill out the CTR application and answer all questions. Charities must also meet one of the following two criteria, as a means of third-party independent review of your charity: 1) Charitable Organizations (501(c)(3)) or that organization's nonprofit charitable affiliates MUST have a Charity Navigator rating of 3 stars or higher; 2) Charitable Organizations (501(c)(3)) or that organization's nonprofit charitable affiliates MUST have a B or better rating and no negative commentary by American Institute of Philanthropy/Charity Watch.

CTR will verify criteria and may deny membership for any charitable organization not meeting the above criteria. In addition, private sector companies or subsidiary companies, which are related to a charitable organization that do NOT meet the above criteria may also be prohibited from joining CTR.
